# ENCOUNTER OVERLAND

**I the undersigned wish to join the expedition mentioned overleaf under the following conditions:**

1. The booking fee is made at the time of booking. The booking fee is accepted as the first instalment of the inclusive fare and will only be refunded if the applicant cannot be offered a place.
2. An interim payment of £200/US\$400/R300 is to be paid not less than 60 days before departure as confirmation of the place.
3. The accepted applicant will pay the balance of the inclusive fare not later than 30 days before the departure of the expedition.
4. If the applicant cancels his/her booking less than 60 days before departure the balance payment can only be refunded if the cancelled place is subsequently filled.
5. The organisers reserve the right to cancel any expedition or places on an expedition without prior notice. In this case all monies paid will be refunded in full.
6. Tour prices and itineraries are subject to alteration without previous notice due to influences beyond the control of the organisers, e.g. exchange rates, epidemics and political disputes and clients should note that the organisers cannot ensure against price differentials of the various currencies acceptable in payment.
7. Charges quoted include meals, living and travel by the means and route indicated or as may necessarily be altered by the organisers. Unless otherwise stated in the expedition details, the price of visas, personal insurance, laundry, admission fees and purely personal spending is not included.
8. Clients will comply with all legislation, immigration and customs and foreign exchange regulations of the countries visited. Should there be any contravention the client may be asked to leave the vehicle.
9. Clients will effect their own travel insurance and are advised that comprehensive vehicle insurance is not necessarily obtainable for all countries visited. Cancellation insurance is strongly recommended.
10. Transport between London and Dover is provided free.
11. Clients acknowledge that this is an undertaking involving a significant element of personal risk and that this overland expedition is a journey of hazardous nature. Clients accept this risk. Neither the organisers, nor the organisers' staff, nor their agents, nor any organisation or carrier with which they are co-operating will be under any unreasonable liability whatsoever.

This contract is subject to English law and is to be interpreted under it in an English Court of Law.

N.B. If you are married and especially if you have children or elderly dependants you are strongly recommended to have arranged extra insurance to cover these responsibilities.
